to
IS 848 : 2006 SYNTHETIC RESIN ADHESIVES
FOR PLYWOOD (PHENOLIC AND
AMINOPLASTIC) – SPECIFICATION**

(Second Revision)

(Page 2, clause 5) – Substitute the following for the existing:

‘ 5 QUALITY OF RESIN ADHESIVES

The resin adhesives shall conform to the following, as applicable:

- a) *Liquid Resin Adhesives* – The adhesives shall comply with the requirements specified in **7**, when the resin and hardener have been stored in closed containers in conditions as specified by the resin/adhesive manufacturer and the adhesive tested within the shelf life.
- b) *Film/Powder Resin Adhesives* – The adhesives shall comply with the requirements specified in **7**, when these have been stored in closed packaging/containers under conditions as specified by the adhesive manufacturer and the adhesive is tested within the shelf life.
