TRAINING PROGRAMMES FOR INDUSTRY TO OBTAIN/OPERATE BIS PRODUCT CERTIFICATION

TRAINING PROGRAMMES ON PRODUCT CERTIFICATION SCHEMES OF BIS FOR APPLICANTS AND LICENCEES

In order to cater to the training need of industry associated with BIS, NITS has developed training programmes for applicant and licensee firms for product certification scheme of BIS. The details of various such programmes is as under:

TRAINING MODULES

In the half day training to applicants, participants are informed of the different procedures for grant of BIS licence, the fee structure, usage of BIS web site, implications of misuse of BIS standard mark, etc.

In the half day training to licencees, participants are apprised of various conditions of operation of licence, application of the Scheme of Testing & Inspection (STI), usage of BIS web site etc.

In the half day training to applicants on Grant of Licence procedures and Operation of Licence, the participants are apprised of licencing procedures, requirements during operation of licence,

implementation of Scheme of Testing & Inspection (STI), usage of BIS web site in operation of licence, fee structure and enforcement activities of BIS.

In the two days product specific training programme for QC personnel of BIS licensees for LPG cylinders, Cement, Cables and Conductors, Electrical switches, sockets & plugs, Plywood & allied products, Packaged Drinking Water, etc, training is imparted about the applicable Indian Standards, the STI and about operation of licence (during the first day of training) and practical training on testing of respective products is imparted in a laboratory (during the second day of training).

TRAINING FEE

Charges for half day programme is Rs 1000/- per participant plus applicable service tax (currently @ 15 %) . For one day programme is Rs 1500/- per participant plus applicable service tax (currently @ 15 %) and for two days programme, Rs 2500/- plus applicable service tax (currently @ 15 %).
